Unless the Supplier/Customer has consented, Foursight Holdings will not sell, exchange, transfer, rent or otherwise make available any personal information about the Supplier/Customer (such as name, address, email address, telephone or fax number) to other parties and the Supplier/Customer indemnifies Foursight Holdings from any unintentional disclosures of such information to unauthorized persons.

Should the Supplier/Customer believe that Foursight Holdings has utilised the Supplier's/Customer's personal information contrary to applicable law, the Supplier/Customer shall first resolve any concerns with Foursight Holdings. If the Supplier/Customer is not satisfied with such process, the Supplier/Customer has the right to lodge a complaint with the Regulator.
